

- ❖ Last date for receiving of application of **26.04.2016 upto 2.00 P.M.** the Tender papers should be available from the office of the undersigned on **4.30 P.M. of 27.04.2016** & the Tender super scribed with the name of work as given in the list of work shall be submitted in sealed cover to this office on date **28.04.2016 upto 1 P.M.**
- ❖ The Tender will be opened on the same day after 2.00 P.M. in presence of the Tenderer or their authorized agents who may be permitted to put their initials.
- ❖ No Tender paper will be issued unless clearance certificate of valid currently granted by the income Tax, Sales Tax & P. Tax which are to be produced along with the application.
- ❖ Earnest money at required amount for each work as indicated in the enclosed list will be deposited in favor of undersigned in the form of Bank Draft (National Bank) along with each tender without which the tender will be treated as informal & cancelled. Accepted tenderer shall have security deduction @ 10% (including E.M) from the Bill which will be refunded after completion security period of works as per norms.
- ❖ The rate should be quoted both in figures & words on percentage below/above/at par of the estimated amount & any correction dully initiated by the contractor. The rate quoted should be inclusive of all taxes & charges. The tenderer should quote their rates after going through the schedule of work & allied specification.
- ❖ Tender once offered cannot be withdrawn within three months from the date of dropping of the same. If any tenderer withdraws his tender before such time, earnest money will be liable to forfeit without assigning any reason.
- ❖ The undersigned reserves the right to relax eligibility criteria as wanted in the interest of work.
- ❖ The undersigned is not bound to accept the lowest & not bound to assign any reason for rejection of any Tender & reserves the rights to distribute the work to more than one if feasible.
- ❖ The S.D .Money will be refunded after three months in the time after the date of completion.
- ❖ Before submission of Tender, Tenderers shall inspect the site & obtain all information regarding the work. Any claim on account of insufficient knowledge on such ground shall not be entertained.

- ❖ If any Tenderer is withdrawing his Tender, before opening, without any satisfactory reason, he may have to face Penal action and deferral from tenders in future as per rules.

- ❖ The tenderer who do not fulfill anyone or all above conditions or incomplete in any respect will be liable to rejection.


